But it can be intimidating to get started when you don't have any experience. Especially since — as Pearl points out — there are scammers out there who like to take advantage of the exciting lifestyle secret shopping offers (even if you only do it once a month).

So here's a simple, easy way to get yourself going.

Rule 1: Never pay anything. If a site or company wants to charge you for entry into their secret shopping program, it's a scam. Full stop. If there is ever the suggestion that you'll need to pay money to the company down the line, walk away. (Paying money in a shop, and getting reimbursed later, is different and usually legit.)

Rule 2: Watch out for too-good-to-be-true promises. Yes — secret shopping can lead to an all-expenses-paid, two-week cruise around the Bahamas. But only after you've proven yourself.

If a site is immediately talking about sending you to Bali, that's a red flag. If, on the other hand, they want you to start with a trip to Jiffy Lube, that's more likely to be on the level.

The glory opportunities will come — but they're almost always reserved for shoppers who have already proven themselves reliable. After all, no cruise company wants to give away thousands of dollars in travel to a shopper who won't deliver the goods.

Rule 3: Find one–three reputable mystery shopping companies and stick with them.

As I mentioned in the article, if a company is a member of the [Mystery Shopping Providers Association](#), you're good to go (there's a company search page on their website).

If you just want to go straight to the source, a few of the most reputed organizations include [BestMark](#), [GBW](#), [Secret Shopper](#) and [IntelliShop](#). All of those are highly regarded — indeed, I've used Secret Shopper and IntelliShop myself.

There are plenty of other good companies out there. Some specialize in certain industries like banks and credit unions. Some are only in the U.S.; most are international. Some are entirely local to a particular region.

When in doubt, you can always google “[Company Name] scam” and see what comes up. A negative review here or there is inevitable, but a mountain of offenses should become apparent for truly bad actors.

Whatever you do, never pay a secret shopping company money... be cautious giving out your information before you trust the company... and start slow and simple before working your way up to the big fish.

But also, get started today. This little side hustle is too much fun — and too lucrative — not to get involved. Save the money you would have spent on that fine dining experience or that cross-country trip and invest it in the profitable assets we cover in these pages every day.
